- F. Any collaboration with the Partner will be guided by this MOU.

**NOW THERE FOR THE PARTIES HERE BY ACKNOWLEDGE AN AGREE AS FOLLOWS:**

1. This MOU is for collaboration between both parties, for mutual benefit, to enhance the quality of the educational experience of Students/Candidates & Helping in project or research works of Parties & for purpose as detailed and mentioned in clause B & C.
2. For the 'Purpose' if any requisite infrastructure or any other facilities needed for the fulfilment of the programme (or any single point under 'Purpose'), it shall be provided by the party or will be mutually decided for the proceeding of such work orally or in written by the parties.
3. Any expenses incurred by the parties for the purpose of this MOU shall be agreed upon and shall be borne as per the mutual agreement.
4. Notwithstanding any other provision of this MOU neither party shall have any right to use any trade marks or trade name of the other party not to refer to this MOU or the obligations performed hereunder directly or indirectly in connection with any product promotion or publication without the prior written approval of the other party.
5. Use of any Trademark or Logo of any party (as under 'Parties') can be subject to be used with a short notice via any medium to communicate whether by electronic or traditional for the purpose of any promotion solely with a good intent.
6. All information which has been disclosed to or opting by either party at any time during the implementation of this MOU is confidential information for this purpose the parties agree to take utmost care of not disclosing any confidential information of either party to any third party (any party other than the 'Parties' as per this MOU).





7. If any 'Party' might have disclosed any so called confidential information of other 'Party', it must be informed to the 'Party' at loss, at the earliest and the steps must be taken to short out the things as far as possible, till not encountered any financial loss.
8. If either 'Party' feels the information or any educational material provided to fulfil the need of 'Purpose', is treated as an Intellectual Property or disclosure of any information mentioned in such educational material provided will hamper or create a financial loss for them, then as a precautionary measure a Non-Disclosure Agreement will come into force, which must be mutually agreed with a sign of an executive or representative of both the 'Parties'.
9. This document is to be mandatorily signed by the authorized person (in case of her/his absence a person appointed by her/him on behalf of such authorized person) of both the 'Parties'.
- 9.1. Required Signature – The document should either be digitally signed or manually signed and shall be supported with the company seal in both conditions.
10. The terms and conditions mentioned herein shall commence on the execution of the MOU and shall continue for a period of five (5) years from the date there of or for such period as may be determined or extended by the parties from time to time by written notice, unless terminated by either party in accordance with this MOU. Either party may terminate this MOU at any time by providing three (3) months written notice to the other party.
11. Any notice required to be given hereunder shall be in writing and shall be deemed to be sufficiently served on the party if sent by hand or by registered post to the addresses of the party as stated in this MOU. Notices shall we deemed to be received:
  - i) If sent by registered mail – three (3) days after posting
  - ii) If by hand at max. on the day next to the delivery
  - iii) if send by telex of fascimile to the correct number or designated address within seventy two (72) working hours. and





If sent by any digital or electronic means: then within next 48 hrs. after receiving the notice.

12. Both parties agree to take all responsible steps to ensure the successful completion of the collaboration and cooperate with each other in carrying out the obligations agreed upon.
13. The expiration and termination of the same MOU will not affect the terms of those activities, which are in progress at the time of notification of expiry or termination of the MOU.
14. On the termination or expiry of this MOU or when requested by URCCA, the partner undertakes to return all materials belonging to URCCA without any delay.
15. Both the 'Parties' agree that URCCA is not obliged on account of this MOU to recruit any fixed number of students/candidates from the partner.
16. This MOU is an indication of good faith and intent on the part of both 'Parties' and does not create any legal obligations between them. In the event of any differences or disputes arising from the implementation of the provisions of this MOU the parties shall as far as possible settle such differences or dispute in good faith by consultation or negotiation between the parties.
17. Save and Except for Clause 4, Clause 7 and Clause 8 this MOU is not a legally binding contract and under no circumstances does this MOU subject either of the parties to liability for breach whether material or minor of contract or any other liability under the laws of the country of the respective parties or any other applicable law.
18. The parties hereby agree that they are not bound exclusively by this MOU and at liberty to enter into any separate agreements or arrangements with any third party without reference to the other party.
19. Any further Agreement between the parties shall be in accordance with this MOU.





Also the dealings on any subject matter other than those mentioned here shall be in accordance in a separate detailed agreement, signed by the parties or their authorized representatives.

20. This MOU also will be used for any future agreements between both the Organization irrespective of it's purpose & can only be not in use if specific nature of work is to be processed where this MOU is not able to guide that agreement.
21. This Agreement will become effective from the date when signed by both Parties.

E) Naresh Technologies & Consultancy Services, the Second Party is engaged in Business, Manufacturing, Skill Development, Internships, Faculty Exchange in the fields of industrial Automation, Embedded systems, IoT, Arduino, Robotics, PCB DESIGN, Machine learning, Artificial intelligence, 3D Printing and related fields in ECE

NOW THEREFORE, IN CONSIDERATION OF THE MUTUAL PROMISES SET FORTH IN THIS MOU, THE PARTIES HERE TO AGREE AS FOLLOWS:

## **CLAUSE 1**

### **CO-OPERATION**

Both Parties are united by common interests and objectives, and they shall establish channels of communication and co-operation that will promote and advance their respective operations within the RISE Krishna Sai Prakasam Group of Institutions and its related wings. The term of Definitive Documents shall be mutually decided between the Parties. Along with the Definitive Documents, this MOU shall represent the entire understanding as to the subject matter hereof and shall supersede any prior understanding between the Parties on the subject matter hereof



## **CLAUSE 2**

### **SCOPE OF THE MoU**

The budding graduates from the institutions could play a key role in technological up-gradation, innovation and competitiveness of an industry. Both parties believe that close co-operation between the two would be of major benefit to the student community to enhance their skills and knowledge.

**Curriculum Design:** Second Party will give valuable inputs to the First Party in teaching / training methodology and suitably customize the curriculum so that the students fit into the industrial scenario meaningfully.

**Industrial Training & Visits:** Industry and Institution interaction will give an insight in to the latest developments / requirements of the industries; the Second Party to permit the Faculty and Students of the First Party to visit its group companies and also involve in Industrial Training Programs for the First Party. The industrial training and exposure provided to students and faculty through this association will build confidence and prepare the students to have a smooth transition from academic to working career. **Faculty Development Programs:** Second Party to train the Faculties of First Party for imparting training as per the industrial requirement considering the National Occupational Standards in concerned sector, if available.

**Placement of Trained Students:** Second Party will actively engage to help the delivery of the training and placement of students of the First Party into internships/jobs; and will facilitate placements for at least 65% of the students. The Second Party will itself absorb at least 75 percentages of the trained students.



Both Parties to obtain all internal approvals, consents, permissions, and licenses of whatsoever nature required for offering the Programmes on the terms specified herein

There is no financial commitment on the part of the RISE Krishna Sai Prakasam Group of Institutions, the First Party to take up any programme mentioned in the MoU. If there is any financial consideration, it will be dealt separately.

### **CLAUSE 3**

#### **INTELLECTUAL PROPERTY**

3.1 Nothing contained in this MOU shall, by express grant, implication, Estoppel or otherwise, create in either Party any right, title, interest, or license in or to the intellectual property (including but not limited to know-how, inventions, patents, copy rights and designs) of the other Party.

### **CLAUSE 4**

#### **VALIDITY**

This Agreement will be valid until 30-06-2025, which it is expressly terminated by either Party on mutually agreed terms, during which period Naresh Technologies & Consultancy Services., the Second Party will take effective steps for implementation of this MOU. Any act on the part of Training Partner or Naresh Technologies & Consultancy Services., the Second Party after termination of this Agreement by way of communication, correspondence etc., shall not be construed as an extension of this MOU.

Both Parties may terminate this MOU upon 150 calendar days' notice in writing. In the event of Termination, both parties must discharge their obligations.

### **CLAUSES 5**

#### **RELATIONSHIP BETWEEN THE PARTIES**

5 .1 It is expressly agreed that First Party and Second Party are acting under this MOU as independent contractors, and the relationship established under this MOU shall not be construed as a partnership. Neither Party is authorized to use the other Party's name in any way, to make any representations or create any obligation or liability, expressed or implied,



on behalf of the other Party, without the prior written consent of the other Party. Neither Party shall have, nor represent itself as having, any authority under the terms of this MOU to make agreements of any kind in the name of or binding upon the other Party, to pledge the other Party's credit, or to extend credit on behalf of the other Party.

Subject to the provisions of Clause below (Dispute Resolution), the courts at Bangalore, India shall have exclusive jurisdiction in relation to all matters arising out of this MOU.





## H) Dispute Resolution

In the event of any differences or disputes arising out of the interpretation or application of the provisions of this MOU, the Parties shall immediately consult each other with a view to expeditiously resolve such differences or disputes in a spirit of mutual understanding and cooperation. Such amicable settlement shall be done within (15) days of the first written communication of the dispute between the Parties.

This MOU is executed in duplicate with each copy being an official version of the Agreement and having equal legal validity.
